here are a lot of spy novels by former intelligence officers, and almost as many legal thrillers by lawyers. And yet there are only a handful of spy novels by intelligence lawyers. In fact, this is a corner of the espionage library that David Bickford seems to have all to himself.

As well he should. David Bickford is a highly distinguished lawyer with a long career providing legal advice to the United Kingdom's intelligence services, both domestic and international. His career advising MI5 and MI6 overlapped with my time as general counsel of the National Security Agency, so I have benefited from his prudence, caution, and wisdom in the law of intelligence.

None of which prepared me for the rampant action and law-breaking in his latest spy novel, Katya. Not to mention the


women's fashion. David clearly has depths I never appreciated when we were comparing intelligence oversight regimes across the Atlantic.

The title character of the book is Katya Petrovna, a British secret agent whose ruthless use of her femininity and guns in pursuit of British interests is matched only by her attention to name-brand accessories. But unlike her predecessor in fiction, James Bond, Katya in the end is out for herself.

The result is nonstop action, pulling Katya from one exotic locale to another – all captured by Bickford with the detailed eye of someone who's been there. Katya finds herself trying to avoid not only gun-wielding thugs but the details of British anti-money-laundering regulation as she tries to make things turn out well for Britain and even better for herself. As they mostly do, but not until after a shootout on the floor of the House of Commons. Even Ian Fleming never imagined that for his hero.

In short, Katya won't just entertain you. It will change forever your view of intelligence lawyers.
